



# Greater Somersworth Chamber of Commerce 2010 Citizen of the Year Award

*The Chamber's Citizen of the Year Award honors a citizen who has demonstrated superior commitment to the region and who has made substantial contributions to the betterment of the Greater Somersworth Area that includes Somersworth, Rollinsford, and the Berwick's of Maine. The award winner is publicly announced in advance of the Award presentation at the Chamber's Annual Dinner on April 30, 2010*

### NOMINATION CRITERIA

- Any person living/working in the Greater Somersworth/Berwick and Rollinsford area is eligible.
- This person contributed to the general benefit of the community as a whole.
- Someone who has demonstrated involvement in the community. For example, in civic affairs, church, PTA, youth sports/activities, or any other non-profit involvement that affects the community.
- Some activities performed should exceed the normal duties of one's paid or salaried position; activities performed in the course of one's normal duties are also considered.
- Services and activities need not be confined to a single year but should be recent enough to have current significance.
- Officers/Directors currently serving on the Board of the Greater Somersworth Chamber of Commerce are ineligible as recipients.
- Winners of the award within the past 5 years are ineligible.
